As One Ministry asks that you make a commitment of six hours of coaching at the cost of \$450.00.

If the total number of hours required to complete the coaching exceeds the six hours there will be an additional cost of \$70.00 per hour. All times are rounded to the full hour.

We have had a 100% success rate when husband and wife are 100% committed to the coaching; therefore As One Ministry makes no guarantees about the success of your unique situation at the onset. Marriage success is accomplished when you both work as one.

Conversations with your coach couple will be held in confidence with the following exceptions A) physical abuse witnessed by an As One Ministry coach B) abuse of a child/children, elderly or mentally ill person C) if your referral was from your Pastor or church leader who request general status of the coaching process. As One Ministry does not recognize any non-constitutional legally recognized "client privileges." Coach couples could be subject to subpoena by a court and required to testify.
